8:45 – 9:45 am **Keynote Address: “Dying with your Values on”, Charles Wellman, MD, FAAHPM, Dolores Christie, PhD.**

Terminal patients often die isolated and with treatable pain and needless suffering. In the last 35 years, the modern hospice movement has made steady progress to address these issues. Even so, as we celebrate successes, there are still barriers to good quality of life before death. It’s a moral imperative to respect patient values and the choices that they dictate. Navigating the waters that separate what constitutes a morally acceptable death from one that diminishes the autonomy and choice of patients continues to be a challenge in the modern medical and legal climate.

9:45 – 10:45 am **Jim Barlow Memorial Lecture: “Responding to Requests for Futile and Potentially Inappropriate Treatments”, Douglas B. White, MD, MAS**

Managing requests for potentially inappropriate treatment is deceptively complex and exposes unanswered questions about the boundaries of good medical practice in patients with advanced illness. This talk will summarize the soon-to-be released guidelines from five major US and European critical care societies on how to respond to such requests and how to proceed in the face of intractable conflict.

1. **“Patients without Proxies: Who’s to Decide”**, Barbara J. Daly, PhD, RN, FAAN

This presentation reviews the ethical norms guiding decision making for patients who lack an authorized surrogate. Advantages and disadvantages of alternative management of clinical situations lacking a proxy will be reviewed. An established procedure used at one medical center will be described and suggestions for future development of community standards discussed.

2. **“Anatomy of an Ethics Consult Note: Developing Competencies”**, Margot M. Eves, JD, Cristie M. Cole, JD

The American Society of Bioethics and Humanities Core Competencies for Healthcare Ethical Consultation (2nd ed) identified the ethics consult note as a key quality component of an ethics consultation service. This session focuses on the elements that should be included in a note in the medical record and provides attendees the opportunity to evaluate sample notes from real cases and formulate a note from a case presented.

3. **“Continuity of Care between In-patient Palliative Care and Home Hospice”**, Robert M. Taylor, MD,

Douglas E. Cluxton, MA, LPC, Lori Yosick, MSW, LISW-S, CHPC

Palliative care (PC) focuses on care for seriously ill patients while providing support and assistance with appropriate goals of care. Hospice, a specific kind of PC, provides supportive care for patients who have decided to forgo disease-directed treatment. As such, the transition to Hospice care can be painful and difficult. This session will explore the medical and ethical challenges inherent in assisting patients and families with this transition to Hospice care. In addition, it will attempt to clarify the benefits of Hospice care and the potential harms associated with inappropriately delaying the transition.

4. **“Autonomy, Capacity and Competency”**, Stuart Youngner, MD

The presenter will discuss competence to accept or refuse treatment in the context of informed consent of which competency is an element. He will demonstrate how competence is socially constructed to balance two important moral principles when they conflict – autonomy and beneficence. Actual cases will be used as illustrations.

5. **“Current Legal Issues in Bioethics”**, Corey Perry, JD, MDiv

Given the ever-changing nature of healthcare and its delivery, jurisdictions and the society-at-large are constantly challenged to create normative standards regarding what and how these services will be delivered. Therefore, it’s critically important to attend to the legal issues that are being raised across the country, as well as within Ohio’s jurisdiction. Several of the most salient and challenging issues nationally as well as changes which have or may yet occur in Ohio will be presented.

6. **“Understanding the Causes of Misperceptions about Prognosis between Clinicians and Surrogates in ICUs”**,

Douglas B. White, MD, MAS

Surrogate decision makers in ICUs often have inaccurate expectations about their loved one’s prognosis, which sometimes leads to conflict with the clinical team about goals of care. These misperceptions have often been attributed to surrogates simply misunderstanding the physician’s prognostications or clinicians failing to disclose prognostic information. This talk will argue that the causes of discordant expectations about prognosis are more complex than this and will require interventions that go beyond clear communication.

7. **“Advance Care Planning: Past, Present and Future”**, Jeff Lyan, RN, BS, MS

This session focuses on various forms of advance planning and decision-making. Discussion will include current status of advance care planning within the state of Ohio and an update on Medical Orders for Life-Sustaining Treatment (MOLST).

In the quarter century since the founding of BENO, ethics consultation has become “routine” in healthcare institutions. What’s been the impact? How does this matter?
